

# 12 reasons to reject the Voice

**1. We are being asked to change our Constitution** that has served Australia well since 1900 and through two world wars. Mr Albanese has been unable to give convincing reasons why we should.

**2. There are: •3,278 Aboriginal corporations •243 Native title bodies •48 Land Councils •35 Regional councils •122+ Aboriginal agencies •3 Advisory bodies •145 Health Organisations •11 Federal aboriginal MP's •Taxpayers give \$100 million a day (\$39.5 Billion yearly) for direct support to 984,000 Aborigines •Expenditure per Aborigine in 2012-13 was \$43,449 compared to \$20,900 for other Australians. Ref: *Indigenous Expenditure Report* 26 Oct, 2017. Estimated 50 year total is about \$660 Billion dollars (2/3 Trillion dollars).**

**3. Over 50% of Australia's land and waters has Native Title** or is claimed. Search '*Native title land + image*' Physically separating us east to west & north to south. NSW has 40,000 claims; Sydney 3,000, one at Balmoral beach valued \$100 million. Mr Albanese is giving \$71 million to fund 3,500 claims against Queensland's Redland Council and refused Council and residents any help or money to defend these claims.

**4. We've given aborigines huge benefits for over 50 years?** This shows we care. Can spending \$364.6 million on a referendum to entrench laws that can only benefit one race, help all Australians?

**5. Missing Millions!** Leonie Brady is part of Port Augusta's aboriginal community of about 3,000 people. Yearly mining royalties bring in millions. When Leonie got cancer she asked ATLA, their Aboriginal management body to help. Their reply was they just didn't have any money. When her grandson needed medical care for leukaemia they gave him nothing. Local Elder, Tiger McKenzie, believes there has been decades of mismanagement. ABC TV 3/5/21

**6. The former chairman of Australia's Aboriginal and Torres Strait Island Commission (1999-2004) Geoff Clark, was twice convicted of rape in Civil Court. He, his wife and a son await trial on 370 Aboriginal Trust fraud issues. [Mail-Times 31.8.23 & Wiki]. The 4 early *national* representative Aboriginal bodies were abolished. Any Constitutional standing of the Voice would stop any such accountability.**

**7. Virtuality every concern that voters have is *already* happening!** Under WA Aboriginal Heritage laws, 2 major tree plantings along Perth's Canning River were cancelled due to aboriginal demands for \$2.5 million for approval. A WA landholder was threatened with 9 months' jail and \$20,000 fine for building a little creek crossing. *ABC News* 16.6.23.

**8. Thousands claim Aboriginal heritage.** Land Council chairman Michael Mansell, "There are thousands claiming to be Aborigine who aren't." Bruce Pascoe, *Dark Emu* author, academic, claims to belong to 3 Aboriginal groups who all say he doesn't. His genealogy, records no aborigines. Of 800,000 First Nations people claimed, aboriginal academic, Suzanne Ingram, "Possibly 300,000 aren't." A *Yes* can cause many High Court cases about aborigine lineage.

**9. The Uluru statement from the heart is 26 pages.** Pages 2 - 26 reveal the full plan for a divisive treaty, rates, land tax, royalties etc. <https://quadrant.org.au> A National Constitutional Convention was held in 2017 to discuss the Voice. 97% of us were not invited. Aborigines only.

**10. To ensure politicians obey their employers, initiate *Binding Citizens Initiated Referendum* laws at all govt. levels.** Such laws allow us to say 'No' to existing and proposed laws; introduce new laws & dismiss those who have lost our confidence. <http://direct-democracy.geschichte-schweiz.ch/switzerlands-system-referendums.html> Search '*Initiative and Referendum*' by Prof. G. **11. Mr G. Clark, former Communist Party of Australia member,** wrote two insightful books on the CPA involvement with Land Rights: '*Red over Black*' and '*The Evidence*'. <https://alor.org> "The CPA has pledged its forces to campaign for a 'YES' vote to further .. struggles for Indigenous rights." **12. Many claims by Aboriginal activist's are unproven.** Aboriginal men and women *did* have the right to vote from 1902: NSW, Vic, SA, Tas. Did Aborigines establish a Nation? The 600 or more separate aboriginal tribes were not a large body of people, united by a common history language and culture, inhabiting a particular country or territory.
